Deerfield River System Wild & Scenic River Study Bill Re-Introduced in the US Congress!

After much effort, the **Deerfield River Watershed Association's (DRWA) initiative** Study Bill seeking National Wild and Scenic River designation for sections of the Deerfield River and its tributaries is once again in the hands of our elected representatives in the US House and Senate.

River Recreation Planning

The DRWA works with our partners and local governments for a safe, clean, and user-friendly river system with adequate public access. Our work includes advocating for river access, improved river safety, adequate restrooms, river cleanups, river trail maintenance, graffiti removal, and improved river recreational facilities.



With a new Congress appointed in 2023, the House and Senate have reintroduced legislation to study sections of the Deerfield River and its tributaries for inclusion in the National Wild and Scenic River System.



On May 21, we plan to lead a hike in search of Pink Lady Slippers and the elusive Yellow Lady Slippers at Mass Audubon's High Ledges Wildlife Sanctuary. Add us on Facebook to stay up to date with all our planned activities.

We have expanded the **Franklin County Rivers Cleanup** to include other river systems throughout the county. We also help coordinate targeted cleanups during other times of the year, including **Earth Day** and the **City of Greenfield - Blue Bag Cleanup Month.**

Yet, there is so much work left to do. Our local rivers urgently need your help.

- Work with our partners to continue improving your river access.
